ASSUMPTION OF RISK:

I am aware that participating in the **Adventure Society Jay Peak Ski Trip 2011** has many inherent risks, including but not limited to: boarding, riding and disembarking ski lifts; changing weather conditions; exposed rock, earth, ice, trees or other natural objects; the condition of snow or ice on or beneath the skiing surface or subsurface; changes or variations in the skiing surface or subsurface, including changes due to man made or artificial snow or ice; impact with ski lift towers, snow making equipment, snow grooming equipment or other structures; impact or collision with other skiers; negligence of other skiers; impact or collision with the ski hill; any injury or illness resulting from exposure to cold, wet or windy weather, or the effects of heat and strong sunlight; any injury resulting from the use, misuse, non-use and failure of any equipment; the failure to ski safely or within one's own ability; failure to follow proper bus loading and unloading guides, I fully understand intoxication and disruptive behavior is not allowed on the bus or ski lifts/hills and drinking is only allowed in public areas if I am 21 and have a valid passport and I.D. to prove such, I understand it is my responsibility to have a VALID passport on the day of departure or my ticket will be null and void and I will not join the trip. VALID meaning I am able to cross over the border and will be responsible for all costs for transportation to return home if I am turned away at the border. The trip will continue without on without me.

I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage or loss, resulting from there from.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury, or expense that I may suffer, or that my next of kin may suffer as a result of my participation in the **Adventure Society Vermont Ski Trip 2012** due to any cause whatsoever INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE;

TO HOLD HARMLESS AND IDEMNIFY THE RELEASEES from any and all liability for any damage to the property of, or personal injury to, any third party, resulting from my participation in the **Adventure Society Vermont Ski Trip 2012**; and

This agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns, and representatives in the event of the death or incapacity.

In entering this Agreement, I am not relying upon any oral or written representations of statements made by the Releases other than what is set forth in this Agreement

I HAVE READ AND UNDERSTOOD THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.
